



### ***2009-2010 MCYHA High School Ice Hockey Information***

#### **Teams**

- MCYHA will field one varsity team, the Bloomington-Normal Sharks Black.
- MCYHA will also field one junior varsity team, the Bloomington-Normal Sharks White.
- Both teams will participate in the Central Illinois Prep Hockey League (CIPHL) as well as tournaments and exhibition games.

#### **Registration**

- The initial registration fee, due by 9/9/09, is \$100, made payable to McLean County Youth Hockey Association (MCYHA). NOTE: \$50 of the registration fee is non-refundable.
- Registration for all players will be held at the Pepsi Ice Center on the following dates/times:
  - Saturday, August 22, 2009 from 10:00 AM – 1:00 PM.
  - Sunday, August 23, 2009 from 11:00 AM – 1:00 PM
  - Wednesday, September 9, 2009 from 7:00 PM – 8:00 PM
- Payments may also be mailed to Diane Wait at 418 Standish Drive; Bloomington, IL 61704, prior to September 9, 2009.
- Total fees have ranged from approximately \$300-\$500 per player over the recent seasons. The total cost is strongly impacted by the amount of involvement in fundraising

#### **Tryouts**

- All players wishing to play high school hockey should attend *all three* tryout sessions, listed below:
  - Wednesday, September 9, 2009 from 8:30 PM – 9:30 PM
  - Thursday, September 10, 2009 from 8:30 PM – 9:30 PM
  - Saturday, September 12, 2009 from 3:10 PM – 4:40 PM
- Any schedule conflicts must be communicated ahead of time to the MCYHA board (contacts listed below) so that alternative arrangements can be made.
